ORDER:

There are 140 training Institutions in the A.P. State imparting M.P.H.W. (F) Training of a duration of 18 months to the Female candidates.

- In their letter 1st read above, the Indian Nursing Council, New Delhi have informed the 2. State Government that the Nursing Council at its meeting held on 26-4-1989 have considered the mushroom growth of Multipurpose Health workers (Female) Training Institutions in the A.P. State and opined that the mushroom growth is leading to sub-standards in Nursing education in the State. The Indian Nursing Council have requested the State Government to take necessary action to stop the mashroom growth of A.N.M./MPHW (F) Training Institutions in the State.
- In their letter 4th read above, the Indian Nursing Council, while furnishing inspection reports have stated that the Inspection teams have inspected 33 training Institutions in the State and found only 4 Institutions as suitable for imparting the training.
- In his letter 2nd read above, the Director of Medical Education has requested the Government to issue an order stoping further permissions to the Multipurpose Health Workers (Female) Training Institutions in the State as this is essentially required to put an end to the mushroom growth of MPHW(F) Training Schools and other connected irregularities, as the number of training Schools and the no. of Trained candidates from the institutions are much higher than the requirements.
- The Government have carefully examined the matter and considered that there is mushroom growth of MPHW (F) Training Institutions in the State and in many of the Training Institutions, basic facilities for impacting such training are not available. They have therefore decided not to accord any further permissions for opening new MPHW (F) Training schools in the State.
- The Director of Medical Education/Director of Family Welfare and Registrar, A.P. Nursing Medical Council are requested not to entertain any applications for permission to open new MPHW (F) Training Institutions in the State.
