- 7. The Nursing Institutions should apply to APNMC before 3 months for expiry of validity to process the permissions in time.
- 8. Teaching Faculty should not move from one Institution to another upto 6 months.
- 9. All the Nursing institutions are hereby informed to furnish their email ID to the APNMC office for future correspondence. Institution is responsible for noticing the circulars in APNMC website.
