DME - APNMC - Original Document Verification and Physical Inspection of existing Nursing Institutions as per the action plan outlined - Documents verified by the team deployed from Medical Colleges & Nursing Colleges - Notices to the Nursing Institutions who have submitted incomplete documents/having deficiencies as per their check list - To pay fee for pending validity with Council - Strict Instructions to follow as per the Government directions & submit compliance within stipulated period of time - Reg.

Report received from the Deputy Director (Nursing), O/o DME, AP, Vijayawada.

Directions from the Government & DME, Govt. of Andhra Pradesh in the review meeting on Nursing Institutions held on 21.03.2025.

In order to streamline the operations of existing Nursing Institutions, the Government have accorded permission to the Director of Medical Education, Government of Andhra Pradesh, to conduct original document verification and physical inspection of existing Nursing Institutions as per the action plan mentioned in the above reference 1st cited.

In this connection, the DME have conducted the original document verification from 02.02.2025 to 19.02.2025 to all the existing Private Nursing Schools & Colleges in the State of Andhra Pradesh.

A review meeting on Nursing Institutions was conducted by the Government on 21.03.2025 and discussed on the outcome of original documents verification.

As per the directions issued by the Hon'ble Minister for Health, Medical & Family Welfare, Hon'ble Special Chief Secretary to Government & Director of Medical Education, Government of Andhra Pradesh, the following strict instructions are passed to submit the compliance within stipulated time period so as to take further necessary action by the Government.

- 1. The Nursing Institutions who are having deficiencies during the process of original document verification (as per the check lists), are instructed to submit their compliance within 2 months of this notice i.e., on or before 24.05.2025. If failed to submit the compliance, it will effect to the Admissions of your College/School of Nursing from this Academic year 2025-26 and the same will be intimated to the Government.
- 2. The Government have given directions to the Council to conduct the physical verification of documents to all the Private Colleges of Nursing by conducting the combined Inspections through Dr.NTRUHS & APNMC. For Schools of Nursing, random Inspections shall be conducted by APNMC. Hence, all the Nursing Institutions (Schools & Colleges of Nursing) should follow this directive and be ready with all the necessary documents in original as per the minimum requirements, to be verified by the appointed Inspectors on the day of Inspection. Inspection proceedings will be communicated through email to speed up this process.
- 3. The Nursing Institutions (Schools & Colleges of Nursing) having pending validity with this Council, including fall in 2025, are informed to pay the fee as per the Council revised fee (see in APNMC website) on or before 03.04.2025 & the documents verification will be verified simultaneously based on the deficiencies found (as per Checklist) on the day of Council's Inspection for issue of further Renewal of Recognitions/other permissions.
