In continuation to the previous Notice issued by this office in the reference-3, all the Principals/Secretary & Correspondents of Nursing Institutions in the State of Andhra Pradesh for MPHWF (F)/ ANM/ GNM/ B.Sc.(N)/ P.B.B.Sc.(N)/ M.Sc.(N) Courses are strictly instructed to submit the applications along with prescribed fee (check in APNMC website, hmis.ap.nic.in) whose validity was already expired or is due to expire in 2025 & to accord the necessary permissions/Recognitions/Renewal of Recognitions.

As per references 1<sup>st</sup> & 2<sup>nd</sup> cited above, APNMC is conducting on Physical Verification of Inspections along with the periodical Inspections duly following the Government directions and to process the pending validity to the Nursing Institutions. The same has already been communicated through Notice in reference-3.

Please note that APNMC will forward only the list of Nursing Institutions with current validity to the respective Admission Boards for this Academic year 2025-26 and Institutions whose validity has already expired will **not be included** in this list. Therefore, **APNMC will not be held responsible for any admissions made by institutions with expired validity.**

All Nursing Institutions in the State of Andhra Pradesh whose validity has expired or is due to expire in 2025 are **instructed to contact the APNMC office immediately** to process their pending validity. Institutions having the latest validity with this Council, may kindly **ignore this notice.**
